## FREE LEGAL RESOURCES FOR SURVIVORS OF TRAFFICKING

Human trafficking exists in many forms and in different industries, including agriculture, domestic service, and sex trafficking. Common to all forms of trafficking is that force, fraud, or coercion is employed or the crime involves child victims.

Survivors of trafficking often encounter a multitude of challenges in recovery, including destroyed credit and criminal records hindering or even preventing survivors from securing desired employment.
