

As a child in the foster care system, I have important rights. It's important for me to know my rights and to speak with a lawyer if I don't.

# I Have the Right to a Lawyer Who Will Fight for Me

#### Here are some other things my lawyer will do for me:




Go to court with me and make sure my voice is heard

## I Have the Right to Go to Court

Going to court is very important.

Judges love meeting kids.

A judge is a person who decides where I live and if and when I can go home.

So this is my chance to SPEAK UP!

If I don't want to talk, I don't have to.

My lawyer will speak for me.

## I Have the Right to Be Placed in a Home with My Siblings

I Have the Right to Visit My Parents and Other Relatives, Unless the Judge Says No




I Have the Right to Privacy with My Personal Belongings

My belongings include my clothes, my backpack, and my journals.


No one's allowed to go through my things without my permission.

# I Have the Right to Save and Use My Own Money



I may have a right to an allowance, depending on where I live. I can put money in and take money out of a bank account.

# I Have the Right to Have Private Conversations with My Lawyer


Everything I tell my lawyer is private. No one should listen to this conversation. Not even a judge can listen to what I tell my lawyer.

This means that if I'm on the phone with my lawyer, no one else should be listening to the conversation.

# I Have the Right to Practice My Religion if I Want




My faith doesn't change just because I enter foster care. I DECIDE if I want to attend religious services with my foster family.

## I Have the Right to Be Respected

"Respect" means no yelling, hitting, or name calling.

I deserve <u>respect</u> from my <u>parents</u> or foster <u>family</u>.

# I Have the Right to Privacy with My Body

NO ONE can touch my body inappropriately.

I have a right to change my clothes by myself.

I have a right to use the bathroom by myself.





If I'm not being respected or if I'm not given privacy, I have to tell my lawyer.

## My Lawyer Can Help

If I feel that someone isn't respecting me or is invading my privacy, I should contact my lawyer right away to let them know.

My lawyer can help me if I'm being disrespected or abused.



# What Kind of Punishments Are OK if I Do Something Wrong?

It's hard to say for sure, but here's what's not OK:

- Being physically punished, such as getting spanked or hit with a belt
- Getting tied up or locked in a room
- Being denied food!
- Getting excluded from family

If something like that happens to me, I'll CALL MY LAWYER!




## I Have the Right to Go to School

I should be able to go to school every day. I have a right to keep going to MY school even if I move.

## I Have the Right to Privacy at School

My teacher can't tell anyone that I'm in foster care. If my teacher breaks this rule, I should tell my lawyer immediately.

# I Have the Right to Keep Doing My Activities

That includes any school clubs and sports teams.

I also have the right to do other activities away from school. I could do things like take a karate class, learn ballet, or be in a play.

## I Have the Right to See Doctors



I can go to a doctor if something hurts or if I feel bad.


I can talk about my feelings with my doctor or my therapist.

I DON'T have to take any medicine that makes me feel really bad or sleepy.

If my teeth hurt, I can go to a dentist as soon as possible.






If I'm having trouble seeing the board at school or with reading, I have a right to see a doctor who can help me get glasses.

Hi, I'm ShyAnn Britt. I'm 18, and I just recently aged out of the system you may be in right now. When I was 14, I was trapped in an abusive home, but when I left on my own I didn't know what to do. I called Child Protective Services for help and I was taken to Child Haven, and there started my journey through foster care. Now I'm about to graduate high school and start college in the fall.

It's not easy being a kid like us—we all come from unique situations, but to make up for the pain, we're helped and cared for by an entire web of people dedicated to seeing us succeed. The important thing is to accept this help, even though it can be hard sometimes. Keep looking towards your future, and trust me, it will get better.

The Children's Attorneys Project received the inaugural Outstanding Children's Law Office Award in 2019 from the National Association of Counsel for Children.
