







Greetings -

Michael is 14. He lives with his disabled grandfather. He is thriving and loves school. He is working in the cafeteria and finally feels he belongs. It wasn't always that way. Michael has autism. His grandfather had been asking for an evaluation and help for Michael, but Michael remained undiagnosed and untreated. Michael was miserable in school. He felt like he didn't belong. He was in a room with emotionally disturbed children and didn't feel he was like them. He loved to run away from the school. He was getting suspended constantly. Finally, Michael exploded at a staff member who was trying to keep him there – a common behavior



for children with untreated autism – so Michael was arrested.

The criminal justice system was not the right place for Michael – he did not belong in criminal court. This child has a disability and was not receiving treatment. The system failed him. That's when Legal Aid Center stepped in. Our attorney met with the school personnel and arranged for an evaluation of his disability. He was diagnosed with autism and received a treatment plan. With our advocacy, Michael was placed in an appropriate school setting. If he continues to do well in school, all charges will be dismissed. His grandfather told us that no one paid attention to him or Michael before we got involved. He is so relieved and feels his child is now safe.

Representing kids like Michael and his grandfather is why Legal Aid Center of Southern Nevada exists. We step into legal crisis after legal crisis, resolving critical situations for the most vulnerable in our community. We right wrongs and change lives. In 2018, we helped more than 125,849 community members and saw significant milestones and achievements which are outlined in this report. Whether you are a staff member, a board member, pro bono attorney, funder, friend, or supporter, we thank you for your support in 2018. Without you, we could not do what we do. And we promise that we will work to make you proud in 2019.

CHILDREN'S ATTORNEYS PROJECT

"Amy was nice. She helped me feel safe and she was very funny."

WHAT WE DO

- Giving children in foster care a voice in court
- Enforcing foster children's rights and desires for visitation with their siblings and for permanency
- Assisting low-income parents struggling to ensure their children with special needs receive the educational support they are entitled to under the law
- Recruiting and training volunteer education advocates to represent the child and protect the rights of disabled children within the school district
- Participating in Autism Court to ensure kids get the education support they need to be successful

STATS

- Represented 5,791 children in foster care
- Expedited the adoptions of 538 kids
- Obtained educational support services for 454 special needs students
- Started #CAP100 Campaign to reach 100% representation of all children in foster care in Clark County

How far would you walk to feel safe? Twin 9-year-old boys with autism and severe developmental delays decided they were willing to walk 500 miles to feel safe. Beaten and scarred by belt buckles, they ran away in the dead of night with \$5.00 and the hope of finding a bus to take them to Oakland, the last place they had felt safe. Two miles into their journey the boys were picked up by the police and turned over to the Department of Family Services.

My name is Jonathan and I am a CAP attorney. I first met the twin boys at Child Haven care facility. They sat on a bench by the playground staring at the ground. No smile, no frown, no crinkled eyebrow, no happiness, no sadness, just flat. I told them I was their lawyer. I told them about my job, about court, about my duty to them. Still nothing. I asked them questions to break their trance: about their favorite game, favorite toy and school. Every answer was "yes" or "no." I went back to the office.

I visited the boys again that week and twice the next week. At each visit they were a little looser, not talkative, but loose. They started giving me high-fives and running towards me when I visited. In week three, I asked them about their dad, who they had been living with, and all the somberness of our first meeting came back into their faces. Then I asked them about their mom, and their faces lit up. Their mom lived in Oakland. The boys wanted to be with their mother.

Mom took an overnight bus to appear in court in person. In Court, the DA and DFS presented reasons why the boys couldn't go home with their mother. The father didn't want the kids to be released to mom. The judge asked me what the boys wanted. I answered, voicing my client's wishes. What the boys wanted mattered to the court, and the judge released the kids to their mother.


I never saw the twins again. About a month after the case closed I received a phone call from Oakland. Granny, mom, and the boys were calling to say "thank you." Their voices were alive and I could hear the smile in their words. The boys said, "Hi, Jonathan how are you?" I knew that I had made an incredible difference in the lives of these kids.

FAMILY JUSTICE PROJECT

WHAT WE DO

- Representing domestic violence victims and helping them obtain protective orders, divorce decrees, and custody of their children
- Teaching victims in domestic violence shelters about their legal right to live a life free of violence
- Representing those unable to navigate the divorce and custody court process
- Helping immigrant victims of crime obtain visas, work authorizations, and status adjustments
- Representing immigrant children eligible for special visas and deferred action to help families stay together
- Partnering with the community in the Family Justice Center (FJC), a one-stop-shop for domestic violence victims

STATS

- Over 1,400 new cases opened in 2018
- Helped over 1,060 victims of domestic violence
- Created High Risk Teams to identify and develop plans for legal and holistic needs
- Assisted 3,082 individuals across all Family Justice Project programs

Elizabeth is a young woman who sought Legal Aid Center's assistance with obtaining a divorce from her husband and primary custody of their 4-year-old son. Elizabeth and her husband were only married a short time when vicious acts of domestic violence began. The last incident of domestic violence resulted in two broken eye sockets, a broken jaw, and contusions. The beating was so severe that Elizabeth has permanent injuries. As a result of this savage beating, Elizabeth's husband, the father of her son, was convicted and imprisoned for five years.

Upon his release from prison, Elizabeth's husband contacted her and began making threats of future violence to her. Elizabeth came to Legal Aid Center for help. We obtained an Order of Protection for Elizabeth for one year and filed her divorce papers.

Elizabeth and her Legal Aid Center attorney focused on completing the divorce and resolving custody issues as quickly as possible. Elizabeth's husband had an attorney and was fighting for joint custody despite the severe level of domestic violence. An attempt was made to reach an agreement between the parties concerning custody but the soon-to-be ex refused anything less than joint custody. A trial was scheduled.

At the conclusion of the trial, Elizabeth was awarded primary physical custody of her son with visitation for his father. Because the father had been in prison for most of his son's life, visitation was set up in stages. Initial visits would be supervised and, provided there were no issues, the visits would move forward in continued stages. Elizabeth is happy to be free from her marriage and have custody of her son.

CONSUMER RIGHTS PROJECT

"The outcome gave me hope — that there really is justice and help out there!"

WHAT WE DO

- Working against fraudulent sales practices
- Fighting abusive debt collection activities
- Helping people trapped in a debt cycle by payday, title, and high interest loans
- Representing workers in bankruptcy court after a job loss and homeowners through the foreclosure process
- Helping people with disabilities who have been denied social security benefits
- Protecting seniors and adults with disabilities from unnecessary guardianships and representing those who have been exploited by their guardians
- Sealing criminal records, filing name changes, and other legal assistance for survivors of sex trafficking

STATS

- Worked on 2,682 cases in 2018
- Guardian Advocacy Program represented over 1,300 individuals
- Assisted 202 families going through foreclosure
- Represented 386 people with disabilities seeking Social Security
- Settled a class action against an entity for breaching the Fair Debt Collection Protections Act
- Began transition for Legal Aid Center to become operator of the Vegas Strong Resiliency Center to ensure all survivors of 1 October have access to assistance they need

Ms. Pierce is a 33-year-old woman with a disability. Her sole source of income is her monthly Social Security check. Ms. Pierce shared a leased apartment with her boyfriend. Things went well in the beginning; however, just months after moving in together, her boyfriend became physically abusive. In October of 2018, Ms. Pierce filed a police report regarding the abuse. She also applied for a temporary restraining order, which was granted. Fearing for her safety, Ms. Pierce moved out of the apartment. However, she was still bound on the lease and could not get her deposit back, causing additional hardships in finding a new place to live.

Ms. Pierce sought Legal Aid Center's help to terminate her lease and sever the connection to her perpetrator. Ms. Pierce gave the landlord the proper notice, the police report, and the temporary restraining order required to be lawfully released from the lease. Instead of releasing her, the landlord gave her two options: one, sign an addendum to the lease acknowledging that she was still obligated for the rent and any damage her perpetrator did to the apartment for the remainder of the lease (he was staying in the apartment), or two, she would be released from owing rent on the remaining term but still be responsible for any damage done to the apartment by her perpetrator for the remainder of the lease. Neither of the options included returning her deposit and fully releasing her from liability under the lease, both of which are required by the law.

Ms. Pierce's Legal Aid Center attorney sent the landlord a letter requesting they release her from the lease, return her security deposit, and hold the remaining tenant liable for any damages as required by the law. The landlord responded within days and released Ms. Pierce from any liability under the lease and refunded her the security deposit. Ms. Pierce is happy to be free from the perpetrator and glad for the help she received.



SELF-HELP CENTERS

The litigant who was filled with fear, who didn't know where to go, what to file, or what her options were – she now goes to the courthouse and finds the Self-Help Center, where her questions are answered, the forms she needs are explained, and the procedure is described to her.



WHAT WE DO

- Providing trustworthy information, legal forms, and assistance to people representing themselves in civil matters such as evictions, small claims court, probate, and lawsuits to recoup losses
- Functioning as a legal emergency room for people struggling to navigate the court system and obtain accurate legal information

STATS

Family Law Self-Help Center assisted a record 49,669 people in person during 2018.

Family Law Self-Help Center website had a record year, with a total of 859,601 users, up by nearly 29%. Those users visited the site 1,258,069 times and viewed over 2.7 million pages!

Civil Law Self-Help Center helped 46,136 individuals in person in 2018.

Civil Law Self-Help Center website use increased by 26% with 1,110,773 users who visited the site 1,452,016 times in 2018 and viewed over 2.6 million pages!

6,270 online Guide & File interviews, designed to assist individuals fill out legal forms, were completed in 2018, nearly double the number from 2017. Currently, 23 online interviews are available.

- 4 new Guide & File interviews allowing litigants to complete forms online through a guided interview were introduced in 2018 at the Family Law Self-Help Center
- 7 new Guide & File online interviews for users filing probate matters and petitions for judicial review were introduced in 2018
- Providing self-help information, legal forms, and instruction to those representing themselves in family court matters
- Hosting a free Ask-A-Lawyer program every week for people needing to speak with an attorney about landlord/tenant, foreclosure, small claims, probate, divorce, custody, guardianship, adoption, or child support issues



ASK-A-LAWYER & OUTREACH EVENTS



SECURING THE FUTURE OF ACCESS TO JUSTICE FOR ALL

When there is a need in our community, Legal Aid Center of Southern Nevada responds. On any given day, Legal Aid Center staff have a stack of new cases on their desks and a lobby full of clients with urgent needs. Ten years ago, Legal Aid Center helped more than 13,000 people. In 2018, we assisted over 125,800! Our community continues to grow. We need to be sustainable, not just now, but for decades to come. We want to leave a stronger Legal Aid Center for the next generation.

In September 2017, we announced the second phase of our long-term growth plan: establishing an endowment fund to allow expansion of our vital existing programs, the addition of new legal specialties, and the creation of a "bridge" for those years when a past funding source may sunset.

THE ENGELSTAD FAMILY FOUNDATION'S \$10,000,000 CHALLENGE GRANT

To begin the endowment campaign, the Engelstad Family Foundation generously seeded the Access to Justice Endowment Campaign with a \$10,000,000 challenge towards the cause of equal justice; the largest single contribution ever given to Legal Aid Center of Southern Nevada.

- For each dollar raised (up to \$5,000,000), the Engelstad Family Foundation will match it \$2-for-\$1
- This 200% match will produce a \$15,000,000 endowment to assist some of Southern Nevada's most vulnerable members: abused children, frail seniors, victims of predatory scams, and domestic violence survivors
- This endowment will provide a stable future for Legal Aid Center, allowing it the flexibility to respond to a crisis in the community efficiently and providing a steady stream of income to protect services during turbulent times

Our community's response to the Legal Aid Center of Southern Nevada Access to Justice Endowment has been overwhelming. By the end of 2018, we have raised **\$4,401,747.50**. The Engelstad Family Foundation match of \$8,803,495 brings our total to **\$13,205,242.50**.

We are \$598,252.50 from obtaining the full match and our goal of a \$15,000,000 Endowment!
